## **Message from the IPCC Committee of Management**



The Irish Peatland Conservation Council's (IPCC) mission is to conserve a representative portion of the peatlands of Ireland for future generations to enjoy. We run the national Save the Bogs Campaign, we own five peatland nature reserves in Kerry, Kildare, Meath and Waterford and we manage the Bog of Allen Nature Centre, which is open to visitors and school groups. We provide an extensive information service on our web site at www.ipcc.ie. IPCC have five members of staff and is supported by 100 volunteers. Four thousand individuals subscribe to our campaign. CHY6829

We are delighted to present the Annual Report and Financial Accounts of the Irish Peatland Conservation Council for 2015.

In this year we completed restoration of 8.5ha of Girley Bog in Co. Meath and drew up a Conservation Action Plan 2016-2025 in partnership with a variety of stakeholders, acquired 10 acres of blanket bog at Coad in Co. Kerry, employed a Campaign Officer and organised over 100 events around the country celebrating bogs.

Our success is due to the support of our donors, volunteers and staff. Thank you all so very much.

### Highlights of 2015

- Acquisition of Coad Bog, Co. Kerry
  - Girley Bog Conservation Plan

IPCC's voluntarv Committee of Management held seven meetings during the year. Our work included regulating IPCC's finances and operations, monitoring health and safety, facilitating an audit of our finances, reviewing the IPCC Strategic Plan, inputting into the Girley Bog Conservation Plan and undertaking staff evaluations. In 2015 we began an internal review of our operations to ensure that we comply with the Governance Code.

The work on Girley Bog was supported by the Heritage **Council and Meath County** Council under the community-

based Heritage Grant Scheme 2015.

### On Lullymore West Bog

in Co. Kildare IPCC recorded four nests of larvae of the Marsh Fritillary (Euphydryas aurinia) butterfly in spring and autumn. A habitat assessment for marsh fritillary was undertaken according to National Biodiversity Data Centre Guidelines and management tasks to improve the habitat for the butterfly will be undertaken in 2016. Twenty two walks of the butterfly transect on the bog were undertaken weekly between April and September. Over the period 854 butterfly individuals were recorded from 19 different species.

IPCC monitored the population and behaviour of Curlew on Lodge Bog, Co. Kildare as part of an all Ireland project on this endangered breeding bird. Three adult birds are present on site. We also monitored the rare Large Heath butterfly on the site recording 26 individuals on a transect walk in June. Restoration of an area trampled by school children was undertaken using the Sphagnum transfer method of transplantation. This project was supported by Kildare County Council Community Heritage Grant Scheme.

Caitriona Smyth from University of California Berkeley made a study of the economic value of the education and recreation ecosystem services of Lodge Bog and presented a community talk during Biodiversity week.

Girley Bog, Co. Meath was a priority in 2015. Through participation in "Girley Bog Meitheal" we completed:

- \* a multi-stakeholder and communitybased Conservation Action Plan 2016-2020 was drawn up for the site. 131 people responded to an on-line survey about the vision and aims of the plan.
- \* delivered three open days to educate local people.
- \* presented a poster paper entitled "Collaborative Conservation of Girley Bog" to the International Peat Society Conference in Tullamore.
- \* organised 5 volunteer workcamps, and completed our

drain blocking programme on the 8.56ha of Girley Bog which we own bringing the total number of dams to 53 in a network of drains covering a distance of 1km.

- \* monitored water levels on the bog in 32 piezometers during the year.
- \* IPCC's restoration of Girley Bog was featured in "The Zoo" broadcast on **RTE** Television in May.

Towards the year end IPCC were gifted 10 acres of blanket bog in Co. Kerry at Coad Bog. The donation was from a supporter and this site will be the focus of extensive work in 2016.

## Monitoring Peatlands in Ireland



During 2015, IPCC responded to 10 site issues documented in the table inset. We made submissions to 7 policy documents (see table inset).

An IPCC representative attended four meetings of the Environmental Pillar in 2015 IPCC voted on a wide range of topics including the membership of People 4 Soil, Government principles for public participation, PEACE IV Monitoring Committee, an MOU between the pillar and SWAN, Climate Change Mitigation Policy, **Bioenergy Principles** and Regional Waste Plans

In addition IPCC liaised with the Public Participation Network representative for Kildare as part of the Local Government Reform programme.

IPCC reported cases of dumping for Lodge Bog & Girley Bog in 2015. Cases were reported to relevant County Councils. Rubbish was removed by IPCC staff and volunteers, Coillte staff and the County Council.

IPCC attended 5 meetings of the Peatlands Council and the Raised Bog Steering Committee to contribute to the work of developing a Peatland Strategy for Ireland and a Management Plan for the Raised Bog SACs. We made submissions to the template documents for raised bog site conservation objectives and the restoration plans.

The Peatlands Council Appeals Sub Group held 5 meetings and reviewed 13 turf cutting cases.

## **Peatland Awareness, Education and Training**

The Bog of Allen Nature Centre is a portal for IPCC's awareness, education and training programmes. Through our in-house and outreach education programmes we impact on a national audience.

The highlights of the year included:

#### 1. International Peat Society Conference Tullamore. IPCC

played a pivotal role in the development and delivery of this conference held in June. We delivered a master class to 100 international peatland experts on Education. Our Chief Executive Dr Catherine O'Connell delivered the welcome speech to participants together with Minister for Foreign Affairs Mr Charlie Flanagan, and we participated fully in field trips fireside conversations about peatlands in Ireland today.

### 2. Ramsar Wetlands Conference, Ballybay Wetland Centre.

IPCC's Education Officer delivered a key note address on the role of the IPCC in peatland conservation to this conference which was attended by officials from the European Union and the Ramsar Convention.

### 3. Grow It Yourself Peat-free Garden at the Bog of Allen.

IPCC received an award for a third year from the Grow It Yourself scheme for our vegetable growing area that is peat free.

### 4. Bog of Allen Nature Centre Visitor Attraction.

IPCC welcomed 1,700 visitors and 28 groups including schools to the nature centre during the year. We organised 9 events at the centre to co-incide with biodiversity week, world animal day, world wetlands day, environment day, heritage week, International Bog Day and culture night. We delivered one teacher training course for primary school teachers.

### 5. Outreach

**Education.** This area of IPCC's work continues to grow from strength thanks to the hard work of Nuala Madigan. We delivered 52 workshops to schools as part of the SEAI

## **Peatland Awareness, Education and Training**



Energy Programme, **Discovering Primary** Science and Math and the Heritage in Schools Scheme. We mounted exhibition stands around the country most notably at the Ploughing Championships, Family Fun Day in Kildare, Fota Island Green Weekend Cork and the Native Species Weekend in Dublin Zoo. We delivered 20 events in liaison with Local Authorities and community groups. We delivered 2 master composter training events with the Stop Food Waste initiative and mounted information stands at the Taste of Cavan and Taste of Monaghan Events. Talks were delivered to the Museum of Country Life and Dublin Food Co-Operative, and training courses on peatlands were delivered in liaison with Ecotourism

Ireland and the National Biodiversity Data Centre.

### 6. Conservation Award for IPCC's Conservation Offi-

cer. Tadhg Ó Corcora was awarded one of the inaugural Allan Robertson Awards for young peatland researchers and managers from the International Peat Society (IPS). The award fund was used to carry out Sphagnum moss transplantation on Girley Bog. A poster paper on Sphagnum moss restoration was presented to the IPS conference in Tullamore.

### 7. Coillte Raised Bog Life Conference.

IPCC's CEO Dr Catherine O'Connell delivered a talk on Scohaboy Bog in Tipperary to the Coillte Conference marking the end of a LIFE-funded project to restore active raised bog habitat in Ireland by removing conifer plantations.

### 8. Flytraps House

**Restoration.** With the provision of a grant from Drehid and Kildare County Council, IPCC organised for the restoration of the greenhouses in the Bog of Allen Nature Centre that house the Flytraps - insect eating plants exhibition. Broken glass panels were replaced after a period of 10 years since the last restoration.

### 8. Signage to the Bog of Allen Nature Centre.

IPCC applied to Kildare County Council for planning permission to erect directional signs in four locations on the roads approaching the Nature Centre. We were successful and signs will be installed early in 2016.

### Press Releases

IPCC issued 19 press releases during the year on a diverse range of topics as shown in the table inset.

#### Media Highlights

IPCC would like to highlight two television programmes in which our work featured during 2015. Our Conservation Officer Tadhg Ó Corcora accompanied Martha Kearney on her Great Irish Journey across the Bog of Allen featuring the work of Du Noyer on BBC1. IPCC's work at Girley Bog was featured on The Zoo programme broadcast in May on RTÉ1 television.

Another highlight was an interview with Dr Catherine O'Connell about *Sphagnum* moss as part of the BBC World War One at Home series (see http://www.bbc.co.uk /programmes /p038f7qq).

Our Education Officer Nuala Madigan contributed a weekly nature feature in the Leinster Leader.

#### Web Site and Social Media

IPCC continue to monitor significant increases in the volume of traffic to our web site, you tube channel and facebook pages which is very heartening (see table inset). During the year we maintained and refined the information on our web site and our on-line shop of 99 products. We were in regular contact with our facebook followers and we uploaded one new film to our YouTube channel which brings to 15 the number of programmes available to view there.

### Volunteers


Volunteers from our nature reserves team were involved in the conservation management of Girley Bog, water level monitoring on Lodge Bog and Fenor Bog and in the butterfly surveys on Lullymore West Bog. 87 volunteers were trained this year on the Girley Bog project alone. Volunteers continue to play a vital role in IPCC's collectors appeal which saw them sorting through over 100kg of

IPCC's volunteer contribution is valued at the level of five additional full time staff. We are very appreciative of all that they do.

### **Fundraising** IPCC made 25 successful funding applications in 2015 to the Heritage Council, Local Authorities, Irish Environmental Network, Grow It Yourself and the International Peat

We conducted a membership drive in 2015 to increase our supporter base. We received a 7% response to our direct mail campaign. The membership drive will continue into 2016.

The surplus for the year, after taxation, amounted to €44,931 (2014 -€739).

### Directors' responsibilities statement

#### 1.1 Basis of preparation of financial statements
